#### Before School /After School Care

Before School Care (7:00AM-7:30AM) Supervision provided by Faculty at no charge to parents.

After School Care (2:30PM – 6:00PM) Supervision provided at a charge to parents.

1<sup>st</sup> Child - \$5.00/hr

2/3 Children \$3.00/hr

Example – 2 children in aftercare would be \$8.00/hr

**Pre-Pay Option**

All families have the option of pre-paying tuition directly to SMA. With one payment, your tuition commitment to SMA will be met. If you choose this option and do so by June 29, 2018 your registration fee will be refunded.

**\*\*The application deadline to FACTS GRANT and Aid Assessment is March 1st\*\***

Financial aid is available to families with children in our **K through 8 programs only**.

**Enrollment/Re-Enrollment:**

\*The \$50.00 registration fee for all students must be submitted with the registration form.

\*All registration fees are NON-REFUNDABLE unless tuition is paid in full by June 29, 2018.

\*There will be a \$25.00 returned check fee for all checks made payable to St. Mary's Academy that do not clear the bank.

**FAC TS Tuition Management Service Overview:**

\*There is an annual non-refundable \$44.00 administrative fee (electronic transfer) or \$44.00 (monthly invoice options) for enrollment in the FACTS program per family. This fee will be added to your tuition collected by FACTS-**please do not make this payment to the school.**

**\* All families who do not pre-pay tuition must enroll in this program.**

\*Pay tuition over 11 months, from July through May, by using the automatic deduction.

\* Payments are made on the 5<sup>th</sup> or the 20<sup>th</sup> of each month.

**\*Your enrollment form to FACTS must be returned with your registration.**

A RETURN FEE OF \$25.00 WILL BE ASSESSED TO YOUR ACCOUNT FOR ANY RETURNED TUITION PAYMENT.

**Withdrawal Policy:**

\*Families must notify the school in writing if a student is withdrawn from school.

\*Registered students who withdraw between July 15th and December 15<sup>th</sup> are responsible for ½ of the full tuition amount.

\*Registered students who withdraw after December 15<sup>th</sup> are responsible for the full tuition amount.

\*The school will not forward records for students who withdraw with an outstanding balance.

**SCHOOL YEAR 2017-2018 CO-CURRICULAR FEE**

(NON-REFUNDABLE FEE).....\$55.00/CHILD

Covers homework planners, additional classroom supplies, religion books, art materials, testing material fees and enrichment activities.
